Course Overview

This course will introduce vehicular ad-hoc networks (VANETs) and facilitate a discussion of issues involved in building VANETs. These issues include physical communications limitations, special characteristics of vehicular networks, possible applications (collision avoidance, incident notification, etc.), security, user privacy, and driver distraction.

Student responsibilities in the course will include reading papers, presenting topics, participating in class discussion, participating in an ongoing research project, and keeping a log of your course activities.

Prerequisites

The main prerequisite for this course is CS 455/555 – Intro to Networks and Communication, or a similar introduction to networking course.

It would be helpful to you (but not required) if you have also taken CS 752/852 - Wireless Communications and Mobile Computing, CS 772/872 - Network Security: Concepts, Protocols and Programming, and/or CS 795/895 – Topics in Vehicular Networks.

Course Materials

There is no official textbook for this course. We will be studying recent academic papers in the field of vehicular networks.

Academic Integrity
